ARTICLES (F INCORPORATION

OF

The undersigned incorporator, for the purpose of forming a corporation for profit under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE 1

Name

The name of the corporation is:

ARTICLE II

Existence

The corporation's existence shall commence upon the filing of these Articles of Incorporation with the Florida Secretary of State.

ARTICE, III

Purpose
