OF

ARTICLE I
NAME

The name of this corporation shall be:
TERI ET AL, INC.

DURATION

The principal office and mailing address of the corporation is 5586 S. W. 28th Terrace, Ft. Lauderdale, FL 33312.



INDEMNIFICATION

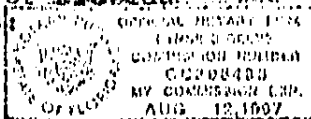


