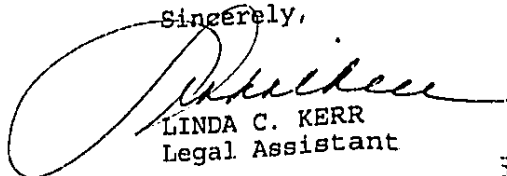

ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this Corporation is CK GOLF, INC., and its business mailing address is 8367 S.W. 137th Avenue, Miami, Florida 33183.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and Florida.

ARTICLE IV - CAPITAL STOCK

ARTICLE VI - INITIAL BOARD OF DIRECTORS

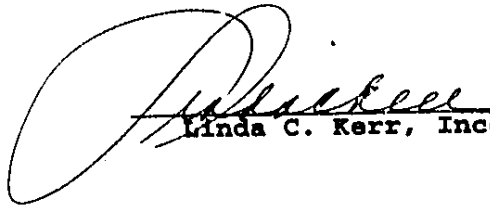

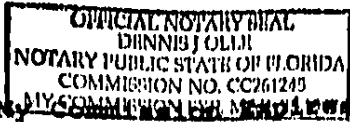
