

ARTICLE I - NAME

The name of the corporation is Carl Brabson Corporation hereinafter called the "Corporation")

ARTICLE II - PURPOSE

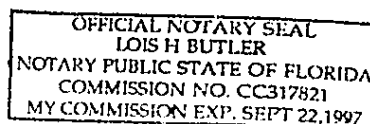
