The undersigned, acting as a incorporator of a Florida corporation under the Professional Service Corporation and Limited Liability Company Act, Chapter 621 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

NAME

The name of the Corporation is DEBRA ANNE JONES, M.D., P.A.

ARTICLE II

DURATION

The Corporation shall have perpetual existence.

ARTICLE III

PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and mailing address of the Corporation shall be 10111 West Forest Hill Boulevard, Suite 221, West Palm Beach, Florida 33414.

ARTICLE IV

PURPOSE

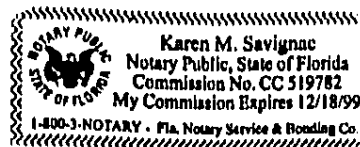
