ARTICLES OF INCORPORATION

The undersigned Incorporator files these Articles of Incorporation in order to form a corporation under the laws of the State of Florida.

ARTICLE I.

NAME

The name of the Corporation shall be Ximango of Quincy, Inc.

ARTICLE II.

DURATION OF THE CORPORATION

The Corporation shall exist perpetually unless dissolved according to law.

ARTICLE III.

CORPORATE PURPOSE

The Corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV.

AUTHORIZED STOCK

The authorized stock of this Corporation shall consist of 1,000 shares of Common Stock with a par value of .10 cents per share. The stock of the Corporation shall be issued for such consideration as may be determined by the Board of Directors, but not less than par value.

Shareholders may enter into agreements with the Corporation or with each other to control or restrict the transfer of stock and such agreements may take the form of options, rights of first refusal, buy and sell agreements, or any other lawful form of agreements.
