

ARTICLES OF INCORPORATION



ARTICLE I - NAME

The name of this corporation is I Love Coffee Wilton Manors, Inc.

ARTICLE II - PRINCIPAL OFFICE

The mailing address of this corporation shall be: Suite 210 4747 North Ocean Drive Fort Lauderdale, Florida 33308

ARTICLE III - PURPOSE
