The undersigned incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be: Guardian Aluminum & Siding Corp.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

893 Vicksburg Street, Deltona, Volusia Co, Fl.

### ARTICLE III CAPITAL STOCK

The corporation is authorized to issue 100 shares of \$1.00 par value common stock, which shares shall be designated "Common Stock." Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series, as that which s/he already holds, shall have the right to purchase his/her prorata share thereof (as early as may be done without issuance of fractional shares) at the price at which it is offered to others.

At inception of this corporation ownership of shares is as follows:

If, at any time, any of the stockholders desire to sell their stock, said stockholder or stockholders shall first offer it, in writing to the Board of Directors, stating prices and terms, and give the Board of Directors Thirty (30) days in which to place it with the stockholders. At the expiration of Thirty (30) days, if no stockholder has purchased and settled for same, said stockholder or stockholders shall have the right to sell to whomever will purchase for the same sum and prices for which it was offered to the Board of Directors.

It is the intent of the incorporator(s) of this corporation that shareholders shall NOT be personally liable for the acts of the corporation.

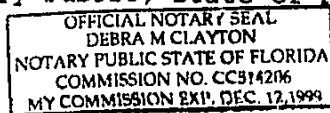

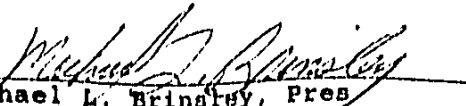
