ARTICIES OF INCORPORATION

OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation is J.F. CONSULTANTS, INC. The principal office and mailing address of this corporation is 7625 Northwest 88th Way, Tamarac, Florida 33321-2426.

The duration of the corporation is perpetual.
