THIRD: The effective date of dissolution of the Company is the date of the filing with and acceptance by the Florida Department of State of these Articles of Dissolution.


FOURTH: The Company is hereby dissolved by the unanimous written agreement of its Shareholder, pursuant to Section 607.1403, Florida Statutes.
