ARTICLES OF INCORPORATION

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I - NAME OF THE CORPORATION

The name of the corporation is SANTINI AIR SERVICES, INC..

The address of the principal office of this corporation shall be 11401 S.W. 145th Avenue, Miami, Florida 33186

ARTICLE II - TERM OF EXISTENCE

The corporation shall exist perpetually, commencing on the date of execution and acknowledgement of this Articles.

ARTICLE III - NATURE OF BUSINESS

The general purpose for which this corporation is organized shall be to operate as aircraft parts broker and flight services company, and provide the related services.

This corporation may engage or transact in any of the lawful activities or business authorized and not prohibited by Chapter 607, Florida Statutes, as the same may be from time to time amended. Provided, however, and notwithstanding the generality of the foregoing, this corporation is not to conduct a banking, safe deposit, trust, insurance, surety, express, building and loan association, mutual fire insurance association, cooperative association, fraternal benefit society, state fair or exposition business.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is 19,000 shares of common stock having a \$.10 par value per share.

ARTICLE V - INITIAL REGISTERED OFFICE & REGISTERED AGENT

The initial street address of the registered office of this corporation in the State of Florida will be 11401 S.W. 145th Avenue, Miami, Florida. The board of directors may from time to time move the registered office to any other address in Florida. The name of the initial registered agent of this corporation at that address is Eduardo J. Insua. The Board of Directors may from time to time designate a new registered agent.

ARTICLE VI - INITIAL BOARD OF DIRECTORS

The initial number of Directors of this corporations shall be two.\

The number of Directors may be increased or decreased from time to time by By - Laws adopted by the stockholders, but shall never be less than one.
