Wo, the undersigned, REAGIN F. PARKER and LAURETTA PARKER, do hereby prepare these Articles of Incorporation for the purpose of forming a corporation for profit as provided under the laws of the State of Florida.

- 1. NAME. The name of the corporation shall be RFP CONSULTING, INC., a Florida corporation.
- 2. <u>PURPOSE</u>. The said corporation is to be in the business of engaging in any and all activities allowable under the laws of the State of Florida.
- 3. GENERAL POWERS. The Association shall have the following powers:
