ARTICLES OF INCORPORATION

OF

MEGATRON, INCORPORATED

The undersigned incorporator hereby files these Articles of Incorporation in order to form a corporation under the laws of the State of Florida.

ARTICLE I.

The name of this Corporation shall be Megatron, Incorporated.

ARTICLE II. Nature of Buginess

The general nature of the business and activities to be transacted and carried on by this Corporation are as follows:

- (a) Including but not limited to sale of goods and market research.

- (e) To issue, execute, deliver, guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge, assign and otherwise deal in and with shares of capital stock, bonds, debentures, other evidences of indebtedness and any and all other


