**ARTICLES OF INCORPORATION**

The undersigned, acting as Incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

**ARTICLE I**

**NAME**

The name of this corporation is **M & M LEASING, INC.**

**ARTICLE II**

**PRINCIPAL OFFICE/MAILING ADDRESS**

The principal office and mailing address of the corporation is 12477 66th Street North, Largo, Florida 34643.

**ARTICLE III**

**SHARES**

The number of shares the corporation is authorized to issue is 5,000 shares par value of \$.01 dollar per share.

**PREEMPTIVE RIGHTS**

also be waived by affirmative written waiver submitted by the shareholder to the corporation within thirty (30) days of receipt of notice from the corporation.

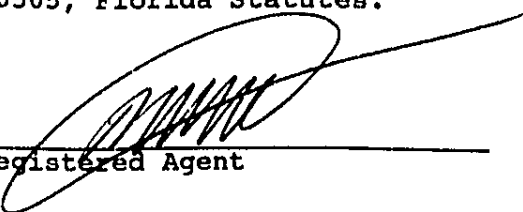
