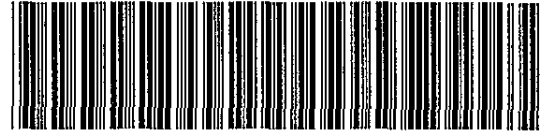




**ARTICLE I
