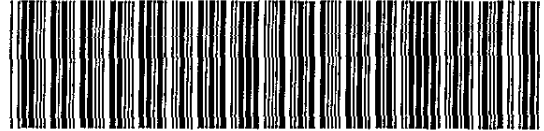

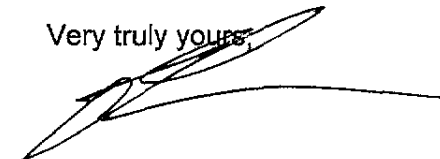

ARTICLES OF INCORPORATION OF

NAME**

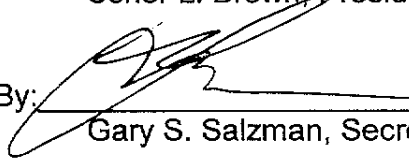
The name of the Corporation shall be **Brown, Ward, Salzman,
