

BROWN, WARD, SALZMAN, WEISS & GARGANESE, P.A., a Florida professional association (hereinafter the "Corporation"), organized and existing under the laws of the State of Florida, filed in the office of the Florida Secretary of State on April 10, 1996, hereby certifies that the directors and shareholders of the Corporation have agreed and consented to amend the Articles of Incorporation to change the name of the Corporation to BROWN, SALZMAN, WEISS & GARGANESE, P.A. After discussion, it was therefore

RESOLVED, that the Articles of Incorporation of the Corporation shall be and are hereby amended so as to change the name of the Corporation to BROWN, SALZMAN, WEISS & GARGANESE, P.A., and that Article I of the Articles of Incorporation for the Corporation shall be amended to read in its entirety as follows:
