DOES HEREBY CERTIFY:

1. That the name of the corporation is Dadeland Software Services, Inc.
2. That by action by written consent of the sole shareholder of Dadeland Software Services, Inc. dated as of April 13, 1998, one amendment to the Articles of Incorporation, as previously amended, of the corporation was duly adopted by the shareholder. The amendment is to Article I of the Articles of Incorporation and changes the name of the corporation from Dadeland Software Services, Inc. to Colonial Software Services, Inc. so that Article I now is as follows:

ARTICLE I – NAME OF CORPORATION

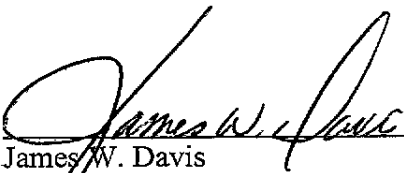
The name of this corporation shall be COLONIAL SOFTWARE SERVICES, INC.
