

ARTICLES OF INCORPORATION

OF

MICRONET TECHNOLOGIES INC.



The undersigned incorporator makes, subscribes, acknowledges and files with the Secretary of State of the State of Florida these Articles of Incorporation, for the purpose of forming a corporation for profit, under the laws of the State of Florida.

ARTICLE ONE

The name of the corporation is MICRONET TECHNOLOGIES, INC.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized are as follows: To transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.
