A provision is provided whereby the Directors at their option may forgo meeting annually and may call a meeting when necessary to conduct the affairs of the Corporation.

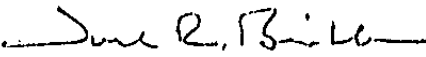
