# ARTICLES OF INCORPORATION OF RUDOLPH ENGR. CORP

WE, THE UNDERSIGNED, hereby certify that we have associated by ourselves together for the purpose of establishing a corporation under and in accordance with the provision of Chapter 607 Florida Statutes, providing for the information, rights and privileges and immunities of the corporation for profit and in pursuance of the terms of said Statutes, we hereby declare and certify as follows:

#### ARTICLE I. NAME

The name of this corporation shall be <u>RUDOLPH ENGR. CORP</u>. The mailing address of the corporation shall be Post Office Box 5480, Spring Hill, Florida 34606.

ARTICLE II.

**DURATION** 

This corporation shall exist in perpetuity.

ARTICLE III.

**PURPOSE**
