**ARTICLE 1
IDENTITY**

SECRETARY OF STATE
TALLAHASSEE, FLORIDA

The name of the corporation shall be **TRHELAND COMPANY**, hereinafter referred to as the "Corporation".

**ARTICLE 2
CAPITAL STOCK**
