ARTICLE VIII - INITIAL BOARD OF DIRECTORS





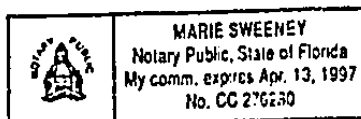
