



Before me, the undersigned authority, personally appeared Manuel Dedios Chamizo who being by me duly sworn deposes and says:

1. My name is Manuel Dedios Chamizo who resides at 10361 Southwest 16 Street Miami, Florida 33165.
2. On November 21, 2000 I became aware of events that led me to conclude that I had been the victim of identity fraud.
3. The individual who has stolen my identity has somehow, without my knowledge or consent, obtained, altered, or produced a copy of my driver license, superimposing his own picture thereon, and represented himself to the public as being me.
4. By this means, this said individual has, among other things, wrongfully and unlawfully filed Articles of Incorporation for a two Florida For-Profit Corporations named Crecer Import and Export, Corp. (Document # P96000031659) effective April 11, 1996 and J.V.M.S. Corporation (Document # P95000078295) effective October 12, 1995 listing me as the Incorporator, Officer, Director and Registered Agent of each.

5. The above referenced corporations are still active Florida corporations as of the date of this Affidavit.
6. I was not aware then and did not authorize and do not presently authorize or consent to being the Incorporator, Officer, Director, or Registered Agent for these corporations.
7. The person who stole my identity has wrongfully and unlawfully been filing Annual Reports with Florida Department of State, Division of Corporations since the inception of each of these corporations and has forged my signature thereon.
8. The addresses listed for Crecer Import and Export, Corp., J.V.M.S. Corporation, and the Officer, Director, and Registered Agent for these corporations do not exist.
9. Any and all other documents previously filed with your office purporting to have been signed by Manuel Dedios Chamizo, Manuel D. Chamizo, and Manuel D. Chamiso, have been forgeries.
10. A report of this incident has been filed with Detective Francisco Perez of the Miami Dade Police Department Economic Crimes Bureau and can be verified by calling 305-994-1048.
11. A criminal investigation by the Miami Dade Police Department is currently underway.
