**ARTICLES OF DISSOLUTION
OF
RENAL EQUITY CORP.**

These Articles of Dissolution are filed pursuant to Sections 607.1402 and 607.1403 of the Florida Business Corporation Act, and provide as follows:

1. The name of the corporation is RENAL EQUITY CORP. (the "Corporation").
2. The Corporation was formed in the State of Florida on April 8, 1996.
3. The Board of Directors of the Corporation proposed dissolution of the Corporation to the Shareholders of the Corporation, and the Shareholders approved the dissolution in accordance with Section 607.1402 of the Florida Business Corporation Act.
4. The Board of Directors and Shareholders of the Corporation authorized the dissolution of the Corporation pursuant to an Action of the Board of Directors and Sole Shareholder by Unanimous Written Consent in Lieu of Special Meeting dated June 30, 2003, and the unanimous consent of all of the members of the Board of Directors and the sole Shareholder was sufficient for approval of the dissolution.
5. All liabilities and obligations of the Corporation have been paid or discharged, or adequate provision has been made therefor.
6. All remaining property and assets of the Corporation have been distributed to the sole Shareholder in accordance with its rights and interest.
7. There are no actions pending against the Corporation in any court, or adequate provision has been made for the satisfaction of any judgment, order, or decree which may be entered against the Corporation in any pending suit.
8. Dissolution of the Corporation shall be effective June 30, 2003.
