The undersigned, for the purpose of forming a Corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I**

The name of the Corporation is **McCRARY & MOSLEY - ORLANDO, P.A.**

The principal place of business is 47 East Robinson Street, Suite 211, Orlando, Florida 32801.

**ARTICLE II**

The purposes for which the Corporation is organized are:  
To engage in the practice of law and to transact any and all lawful business for which corporations may be organized under the Florida General Corporation Act and/or permitted under laws of the United States.

**ARTICLE III**

The duration of the Corporation shall be perpetual.

**ARTICLE IV**

The aggregate number of shares that the Corporation has authority to issue are 1000, all of which shall be common shares with par value of \$0.00.

**ARTICLE V**

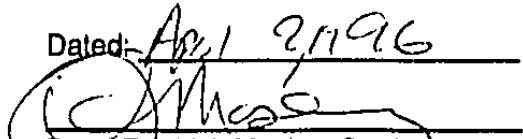

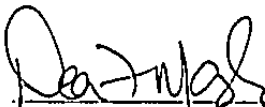
