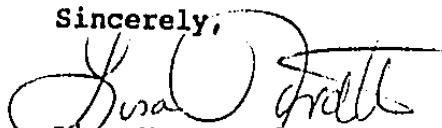

EFFECTIVE DATE

ARTICLE I - NAME & ADDRESS

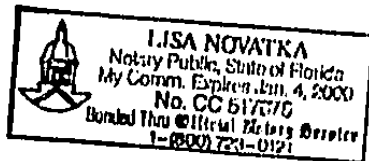

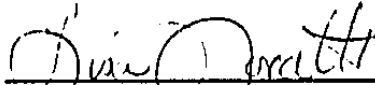

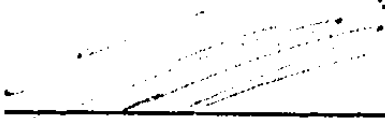
