

ARTICLES OF INCORPORATION OF SUSAN AKS, INC.

THE UNDERSIGNED SUBSCRIBERS TO THESE ARTICLES OF INCORPORATION, EACH A NATURAL HERSON, COMPETENT TO CONTRACT, HEREBY ASSOCIATE THEMSELVES TOGETHER TO FORM A CORPORATION FOR PROFIT UNDER THE LAWS OF THE STATE OF FLORIDA! AND DO AGREE TO THE FOLLOWING CONDITIONS OF SAID CORPORATION:

ARTICLE I: NAME

THE NAME OF THIS CORPORATION SHALL BE: SUSAN AKS, INC. BUSINESS SHALL BE CARRIED ON IN ERGWARD TOUNTY, FLORIDA AND ALSO WITHIN AND WITHOUT THE STATE OF FLORIDA, AND IN THE UNITED STATES OF AMERICA AND FOREIGN COUNTRIES AS MAY FROM TOME TO TIME BE DEEMED DESIREABLE OR EXPEDIENT:

ARTICLE IDI: CAPITAL STOCK

ARTICLE X: AMENDMENT
