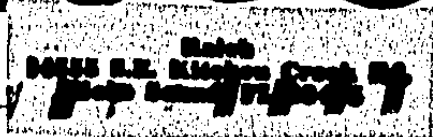

ARTICLES OF INCORPORATION  
OF  
FLORIDA CONSTRUCTION REFERENCE SERVICES, INC.

I, the undersigned, do hereby file these Articles of Incorporation for the purpose of becoming a corporation under and pursuant to the laws of the State of Florida providing for the formation, liability, rights, privileges and immunities of a corporation for profit, and for that purpose I do hereby certify, declare and set forth as follows, to wit:

ARTICLE I

NAME

The name of the Corporation shall be:

FLORIDA CONSTRUCTION REFERENCE SERVICES, INC.

ARTICLE II

GENERAL NATURE OF BUSINESS

The general purposes for which the corporation is organized are:

1. To transact any lawful business for which corporations may be incorporated under the Florida General Corporations Act or engage in any other trade or business which can, in the opinion of the Board of Directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.
2. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing:

ARTICLE III

CAPITAL STOCK

The Capital stock of this Corporation shall be five hundred (500) shares of ONE DOLLAR (\$1.00) par value, which shall be designated "Common Shares."

ARTICLE IV

VOTING RIGHTS

Except as otherwise provides by law, the entire voting power for the election of directors and for all other purposes shall be vested exclusively in the holders of the outstanding Common Shares.

ARTICLE V

CORPORATE EXISTENCE

This Corporation shall exist perpetually unless sooner dissolved according to law.

ARTICLE VI

PRINCIPAL PLACE OF BUSINESS

The principal place of business of FLORIDA CONSTRUCTION REFERENCE SERVICES, INC., shall be 14555 SE Kitchen Creek Rd, Hobe Sound, Florida 33455, and its mailing address shall be P.O. Box 670, Hobe Sound, Florida 33475, with the privilege of having branch offices at other places within or without the State of Florida.

ARTICLE VII

REGISTERED OFFICE AND REGISTERED AGENT

The street address of the initial registered office of this Corporation shall be 14555 SE Kitchen Creek Rd, Hobe Sound, Fl 33455, and the name of the initial registered agent of this Corporation at the address shall be MARY RAICH.

ARTICLE VIII

DIRECTORS

The name and post office address of the first Director who shall hold office for the first year or until his successors are chosen shall be:

Directors of FLORIDA CONSTRUCTION REFERENCE SERVICES, INC., shall

have the power to make or amend the by-laws and to fix any amount to be reserved for working capital.

This Corporation shall have at least one but not more than five directors, and no person shall be required to own, hold or control stock in the Corporation as a condition precedent to holding an office of this Corporation.

ARTICLE IX

INCORPORATOR

The name and address of the person signing these Articles of Incorporation is MARY RAICH.

ARTICLE X

BY-LAWS

The power to adapt, alter, amend or repeal by-laws shall be vested in the Board of Directors and the shareholders.

ARTICLE XI

Every shareholder, upon the sale for cash of any new stock of this Corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his prorata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE XII

This Corporation reserves the right to amend, alter, change or repeal any provisions contained in these Articles of Incorporation in the manner now or hereafter prescribed by statute.

The private property of the stockholders shall not be subject to the payment of the corporate debts in any extent whatsoever. The Corporation shall have the first lien on the shares of its members and upon the dividends due them for any indebtedness of such members to the Corporation.



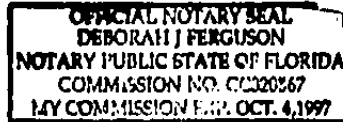
