ARTICLES OF INCORPORATION

ARTICLE I - NAME

SECRETARY OF STATE

The name of this corporation is New Beginnings Home Health Counseling, Inc.

ARTICLE II - PRINCIPAL OFFICE

This corporation is organized for the purpose of transacting any or all lawful business.
