ARTICLES OF INCORPORATION
OF

We, the undersigned, do hereby submit these Articles of Incorporation for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State providing for the formation, liability, rights, privileges and immunities of a Corporation for nonprofit.

ARTICLE I.

ARTICLE II.

This Corporation shall exist perpetually unless dissolved according to Florida law.
