San Control of the Co The undersigned hereby subscribes to these Articles of Incorporation for the purpose of forming a professional service corporation pursuant to the Professional Service Corporation Act, Florida Statutes, Chapter 621.

ARTICLE_I

NAME

The name of this corporation shall be as set forth above.

ARTICLE II

GENERAL NATURE OF BUSINESS AND POWERS
