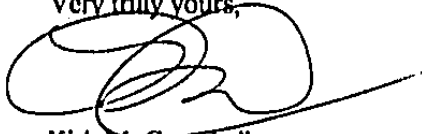

**Article I - Name**

The name of the corporation is: Delivery Services Company, Inc.

**Article II - Duration**

This corporation shall exist perpetually.

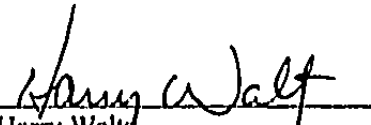

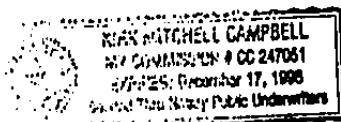
