

ARTICLES OF INCORPORATION

The undersigned, for the purpose of organizing a Florida Profit Corporation adopt the following Articles of Incorporation:

1) The name of the corporation is John Geer Carpentry, Inc.

2) The duration of the corporation is perpetual.
