The corporation may transact any and all lawful business for which corporations may be incorporated under the laws of the United States and the State of Florida.

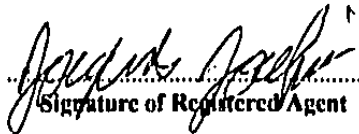
