**ARTICLES OF INCORPORATION
OF
SUNSHINE STATE CONNECTION, INC.**

The undersigned incorporator, being a natural person competent to contract,
hereby adopts these Articles Of Incorporation in order to form a corporation under the
laws of the State of Florida.

ARTICLE I

The name of this corporation is Sunshine State Connection, Inc.

ARTICLE II

The corporation shall commence upon the execution of these Articles and shall exist
perpetually.

ARTICLE III

The purpose of this corporation is to engage in the transaction of any and all business
permitted under the laws of the United States and the laws of the State of Florida.

ARTICLE IV

The corporation is authorized to issue three thousand (3000) shares of one dollar (\$1.00)
par value common stock. The rights attendant to all such shares, once issued shall be
identical in all respects. The shares of this corporation are not to be divided into classes.
This corporation is not authorized to issue shares in series or in less than whole shares.

ARTICLE V

Every Shareholder, upon the issuance of new stock of this corporation for any reason shall

have preemptive rights; the right to purchase his or her pro-rata share thereof, as nearly as can be done without issuing fractional shares, at the price at which the shares are being offered to others.

ARTICLE VI

The initial street and mailing address of the principal place of business of the corporation shall be 11030 Sandpiper Court, Tamarac, Florida 33321. The initial address of the registered office of this corporation is 5200 West Newberry Road, Suite E-6, Gainesville, Florida 32605. The name of the initial registered agent is J. Kyle Bachus.

ARTICLE VII

The initial Board of Directors shall consist of three Directors initially. The number of Directors may be either increased or diminished from time to time by the Shareholders but shall never be less than one. 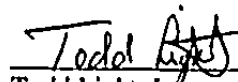

ARTICLE X

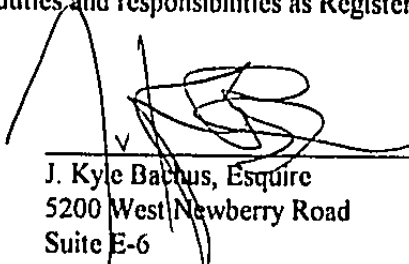
The Board of Directors shall have the power to amend or supplement these Articles of Incorporation when approved by a majority vote of the Shareholders.
