# ARTICLES OF INCORPORATION OF ORION MANAGEMENT GROUP, INC.

The undersigned subscribers to these articles of incorporation, natural persons competent to contract, hereby act to form a corporation under the laws of the State of Florida SEGNALIA, OF STATE TALLAHASSEE, FLORIDA

### ARTICLE I, NAME

The name of this corporation is ORION MANAGEMENT GROUP, INC.

#### ARTICLE II. NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is:

Any or all lawful business for which corporations under Chapter 607, Florida Statutes, may be organized, and shall have all powers now or hereafter granted to corporations or exercisable by corporations, pursuant to Chapter 607 or other provisions of law.

To manufacture, purchase, or otherwise acquire, and to own, mortgage, pledge, sell, assign, transfer or otherwise dispose of, and to invest in, trade in, deal in and with, goods, wares, merchandise, real and personal property, and services of every class, kind, and description; except that it is not to conduct a banking, safe deposit, trust, insurance, surety, express, railroad, canal, telegraph, telephone, or cemetery company, a building and loan association, mutual fire insurance association, cooperative association, fraternal benefit society, state fair or exposition.

To conduct business in, have one or more offices in, and buy, hold mortgage, sell, convey, lease, or otherwise dispose of real and personal property, including franchises, patents, copyrights, trademarks, and licensees, in the State of Florida and in all other states and countries.

To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidences of indebtedness, and execute such mortgages, transfers of corporate property, or other instruments to secure the payment of corporate indebtedness as required.

To purchase the corporate assets of any other corporation and engage in the same or other character of business.

To endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire or dispose of the shares of the capital stock of, or any bonds, securities, or other state or government, and while owner of such stock to exercise all rights, powers and privileges of ownership, including the right to vote such stock.

The stockholders, by simple majority of ownership of shares, may by agreement recorded in the minute book of this corporation impose such restrictions on the subscribers to such agreement as they may see fit. Any contract or other transaction between the corporation and one or more of its directors, or between the corporation and any firm of which one or more of its directors are members or employees, or in which they are interested, or between the corporation and any corporation or association of which one or more of its directors are shareholders, members, directors, officers, or employees, or in which they are interested, shall be valid for all purposes, notwithstanding the presence of such director or directors at the meeting of the Board of Directors of the corporation, which acts upon, or in reference to, in such action, if the fact of such interest shall be disclosed or known to the Board of Directors and the Board of Directors shall, nevertheless, authorize, approve or ratify such contract or transaction by a vote of a majority of the directors present. This corporation may also reimburse to any director, officer, or employee the reasonable costs of settlement of committee composed of the directors of this corporation not involved in the matter in controversy (whether or not a quorum) that it was to the interests of this corporation that such settlement be made and that such director, officer, or employee was not guilty of negligence or misconduct. Such indemnification or reimbursement shall not preclude such director, officer, or employee from exercising any rights to which he may be entitled under the by-laws or otherwise.
