ARTICLE V - DIRECTORS

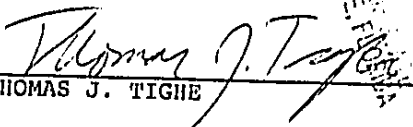

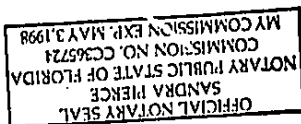

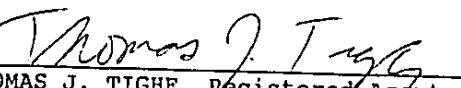
