The undersigned does hereby execute, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I

The name of this Corporation shall be as follows:

ARTICLE II

This Corporation shall commence its existence on the date these Articles of Incorporation are filed.

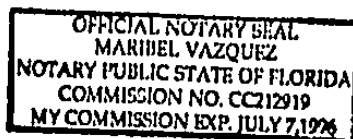
