Pursuant to the provisions of the Florida Business Corporation Act, the undersigned, being of at least 18 years of age and acting as the incorporator of the corporation hereby being organized thereunder, certifies that:

FIRST: The name and address of the corporation (the "corporation") is Huss-Zwingli Publishing, Inc., 6706 Pinehurst, North Lauderdale, FL 33068.

SECOND: The purposes for which the corporation is organized are to engage in any lawful business activity or activities whatsoever within the purposes for which corporations may be organized under the Florida Business Corporation Act and to have all of the powers conferred upon corporations organized under said Act.

THIRD: The name and address of the initial registered agent and registered office of the corporation within the State of Florida is CT Corporation, 1200 South Pine Island Road, Plantation, FL 33324.

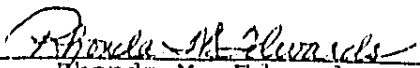
SIXTH: The name and address of the sole incorporator of the corporation is Rhonda M. Edwards, LeBoeuf, Lamb, Greene &
