The undersigned signer of these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I

NAME

The name of the Corporation is PROFESSIONAL LANDWORKS, INC..

ARTICLE II

STREET ADDRESS

ARTICLE III

NATURE OF BUSINESS

The general nature of the business to be transacted by the Corporation is: landscaping, excavation, grading construction of all kinds, and all other related purposes. Provided, however, this purpose shall not restrict or limit the Corporation in any way in the transaction of any and all lawful business for which Corporation may be incorporated under the laws and statutes of the State of Florida.

To do all and everything necessary, suitable or proper for the accomplishment of any of the purposes, the attainment of any of the objects, or the exercise of any authority herein set forth, either alone or in conjunction with other corporations, firms, or individuals, and either as principal or agent, and to do every other act or acts, things or things, incidental or appurtenant to or growing out of or connected with the above-mentioned objects, purposes, or authority.

Nothing contained herein shall be construed as limiting or restricting in any manner the authority of this Corporation.

ARTICLE IV

CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to issue is Five Thousand (5,000) shares of common stock with no par value. Such shares shall be of a single class. Such stock may be issued from time to time without action by the stockholders, for such consideration as may be fixed from time to time by the Board of Directors, and such shares so issued, the full consideration for which has been paid or delivered, shall be deemed full paid stock.

ARTICLE V






