The undersigned, acting as incorporator of a Corporation under the Florida General Corporation Act., adopts the following Articles of Incorporation for such Corporation.

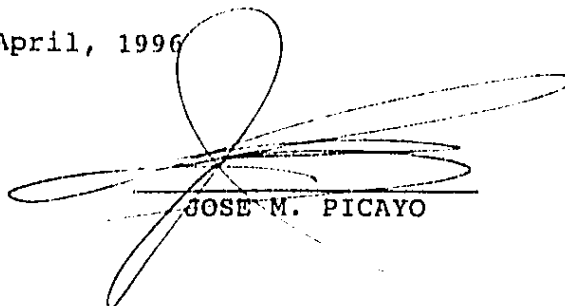
ARTICLE VII

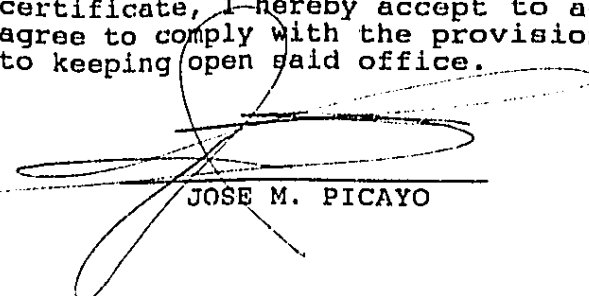
