

ARTICLES OF INCORPORATION

OF

SUPER SKATES IV, INC.

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be: SUPER SKATES IV, INC.

The address of the principal office of this corporation shall be 1378 Southwest 160th Avenue, Bay E5, Sunrise, Florida 33326, and the mailing address of the corporation shall be the same.

ARTICLE II. NATURE OF BUSINESS

It is the intent of the Incorporator that the corporation will qualify under section 1244 of the Internal Revenue Code.


