

ARTICLE I: NAME

The name of this corporation is ARTISTIC PAVERS, INC.

ARTICLE II: DURATION

This corporation shall have perpetual existence commencing on the date of it's actual operation.

ARTICLE III: PURPOSE

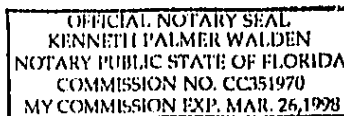


