ARTICLES OF INCORPORATION

OF

NATIONAL PRODUCTS & SERVICES, Inc.

Story The State of The undersigned, acting as incorporator, signs the following Articles of Incorporation for the purpose of forming a comporation under the laws of the State of Florida.

ARTICLE_I

The name of corporation shall be: National Products & Services, Inc. (hereinafter the "Corporation").

ARTICLE_II

The existence of the Corporation shall commence upon the filir.g of these Articles of Incorporation by the Department of State and shall be perpetual.

ARTICLE III

The Corporation may engage in any and all businesses and activities permitted by the laws of the State of The Corporation shall have all of the powers Florida. vested in a corporation organized under and existing by virtue of such laws.

ARTICLE_IY

The maximum number of shares which the Corporation shall have authority to issue shall be 10,000 shares of common stock with a par value of \$0.10 per share.
