

## ARTICLES OF INCORPORATION

OF

### GraTon, Inc.

BY THESE ARTICLES OF INCORPORATION, the undersigned acting as interperated pursuant to the Florida General Corporation Act, forms a corporation for profit.

## ARTICLE I

The name of this corporation shall be GreTon, Inc.
