PR COMMUNICATIONS, INC.

The undersigned, acting as Incorporators of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation:

1. **NAME.** The Name of the corporation is PR COMMUNICATIONS, INC.
2. **ADDRESS.** The initial address of the principal office, business office, and mailing address of the corporation is:

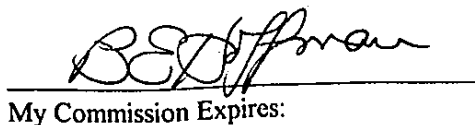

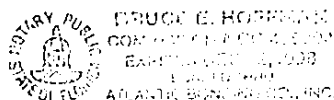
