ARTICLES OF INCORPORATION

OF

BKL & ASSOCIATES, INC.
A Florida Corporation

ARTICLE I NAME

The name of the Corporation is: BKL & ASSOCIATES, INC. a domestic corporation which is not a member of any affiliated group.

ARTICLE II PRINCIPAL OFFICE

The principal place of business of this corporation shall be: 13201 Laraway Court, Riverview, FL 33569.

ARTICLE III PURPOSE

The general purposes for which the Corporation is organized are:

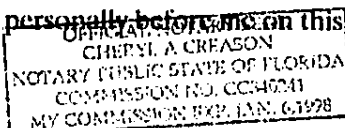
