OF
AMENDED AND RESTATED

Pursuant to the provisions of Section 607.1006, Florida Statutes, Ackerman Law Group, P.A., a Florida professional association (the "Association"), hereby amends its Amended and Restated Articles of Incorporation, as follows:


FIRST: Article V is hereby amended to read:

ARTICLE V
PURPOSE
