ARTICLES OF INCORPORATION

OF

INTER-AMERICAN TECHNICAL SERVICES IN .

The undersigned, acting as incorporator of inter-American Technical Services (ITS) under the Florida General Corporation Act, adopts the following Articles of incorporation.

ARTICLE I. NAME

The name of the corporation is: INTER-AMERICAN TECHNICAL SERVICES, INC.

ARTICLE II. DURATION and COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence on the date of filing of these Articles of Incorporation. The corporation is to exist perpetually.

ARTICLE III. PURPOSE
